Procedure for Application (Grades K-12)

Read and sign the Tenets of Faith page and complete the Application.

Submit the Tenets of Faith page and completed Application to the Academy with the following:

- 1) copy of student's most recent report card
(for kindergarten enrollment, a pre-school evaluation, if available)
- 2) copy of social security card
- 3) copy of birth certificate
- 4) copy of current immunizations

For students entering grades 1-12 or mid-year K...

If application is being made during the school year while school is in session, we will try to arrange a day for the student to visit AFTER the above listed documents are received. From this visit we will be better able to determine how the student fits into our program, both academically and socially. After the visit, the student and parents must meet with the CCA Principal for an interview, which could be lengthy.

For students entering grades 1-12...

If application is being made during the summer when school is not in session or if a classroom visit is not possible, an interview with the Principal will be the next step AFTER all the above documents have been received. This interview could be lengthy. Parents and student(s) are to attend.

At some point, you will be asked to sign a release of information from the student's previous school releasing copies of all academic and disciplinary records. Final acceptance will be pending receipt and review of these documents.

For students entering kindergarten... Once the above documents have been submitted, an interview may be requested.

Once you have been notified that the student has been officially accepted into Cheswick Christian Academy, **the enrollment fee and first month's tuition must be paid to finalize the enrollment**. These payments must be made before the student will be permitted to attend the first day of school, but are officially due **by August 20th** for the start of a new school year. There will also be a few more forms that will need to be completed (emergency contact information, transportation request, official release of records to prior school, etc.) after acceptance is final. Transportation requests (for busing from your district to CCA) take some time to process, so if you plan to utilize busing, we suggest that you do not procrastinate with the enrollment process.

We believe that the only means of being cleansed from sin is through repentance and faith in the precious blood of Christ. We believe personal salvation shall be given to all who have repented of their sins, who have believed on the Lord Jesus Christ to the saving of their souls, have given clear evidence of their salvation, and are thus born again (2 Cor. 5:17, Rom. 6:3-5, Col. 2:12, & John 3:3-7). We believe that regeneration by the Holy Spirit is absolutely essential for personal salvation. We believe in the ordinance of baptism by immersion in water (Mt. 3:16 & Mark 2:19). We believe that the redemptive work of Christ on the cross provides healing of the human body in answer to believing prayer. We believe that the baptism of the Holy Spirit, according to Acts 2:4, is given to believers who ask for it. We believe in the sanctifying power of the Holy Spirit by Whose indwelling it is that the Christian is enabled to live a holy life. We believe in the ordinance of the Lord's Supper, and it shall be observed regularly as enjoined by Scripture (Lk. 22:19 & I Cor. 11:23-26). We believe in the resurrection of both the saved and the lost, the one to everlasting life and the other to everlasting damnation.
